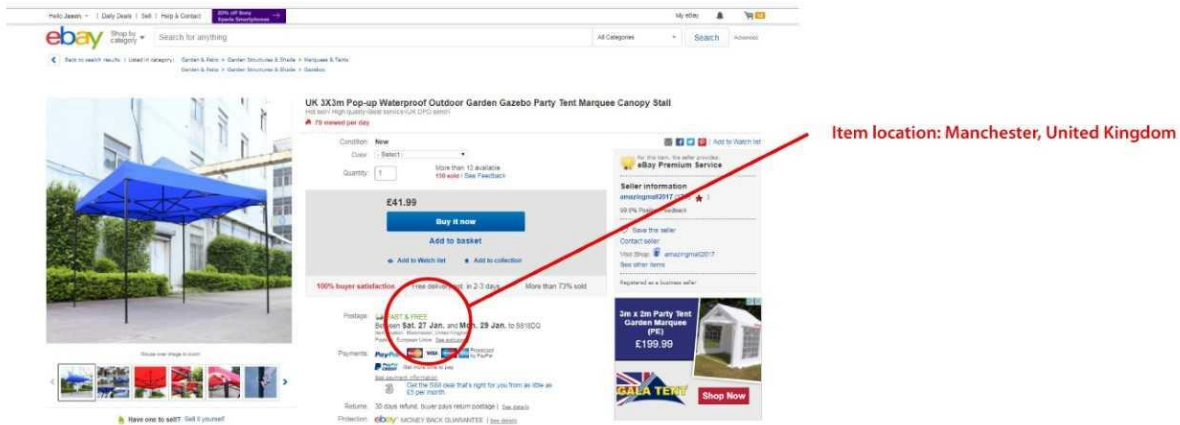




eBay Pop Up Gazebo Buying Guide

Here you see a company selling on eBay, the location is listed as **Manchester UK** which means this will appear to anyone in the UK searching for a Pop Up Gazebo




Below is a screen shot of the same eBay listing, when you scroll down the listing page, you can identify that the company is clearly located in **Shenzhen China**. This means that if you buy the item and you are not happy with the quality, and you would like to return it, you would be responsible for the total cost of the return postage, which would obviously be quite expensive due to the size, weight and distance the pop up gazebo will have to travel back to China. So, you are now stuck with it, and if the pop up gazebo is not suitable for purpose, then you have just thrown away your hard earn cash!

- And what are you going to do if you require any spare parts?
- And for some reason eBay allow sellers to hide and deceive buyers of the TRUE company location in the product listing, so awareness is required.

Return Accepted:

3. All returned items must be complete, in the original packaging and in an unused re-saleable condition. A full refund of the order total will be made using the original payment method. Please be advised that you will be responsible for the cost of the return postage.
4. If the item is faulty, dead on arrival (DOA) then we commit to issuing you with a working replacement within the warranty period and must be reported within 5 days from delivered date.

If in the event that a replacement is not available then we will issue you with a full refund.
